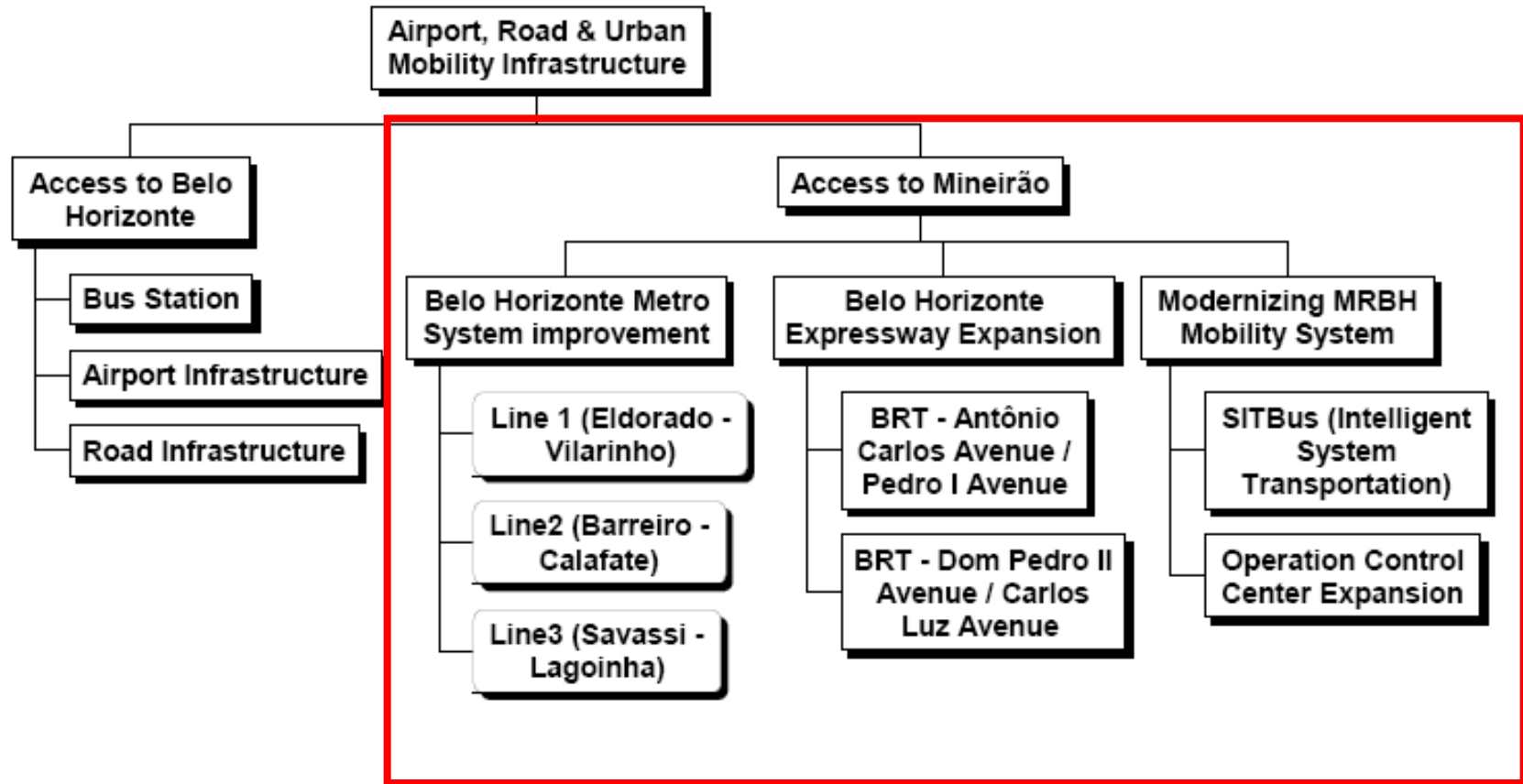

# Minas Gerais and Belo Horizonte – building a new time.

- » 587 thousand Km<sup>2</sup>, distributed among 853 municipalities
- » Population: 20 million
  - » Urbana: 84,6%
  - » Rural: 15,4
- » Capital: Belo Horizonte: 2,4 millions
  - » Metropolitan region: 4,9 millions
- » GDP: US\$ 130 billions, 9% of Brazil´s GDP
  - » Agribusiness: 8,8%
  - » Industry: 33,4%
  - » Services: 57,8%

## Main actions:

- Implementing Bus Rapid Transit systems (BRTs)
- Expanding MRBH Metro lines
- Modernizing MRBH Mobility System



# Implementing Bus Rapid Transit systems (BRTs) for stadium access corridor

## Corridor 1:

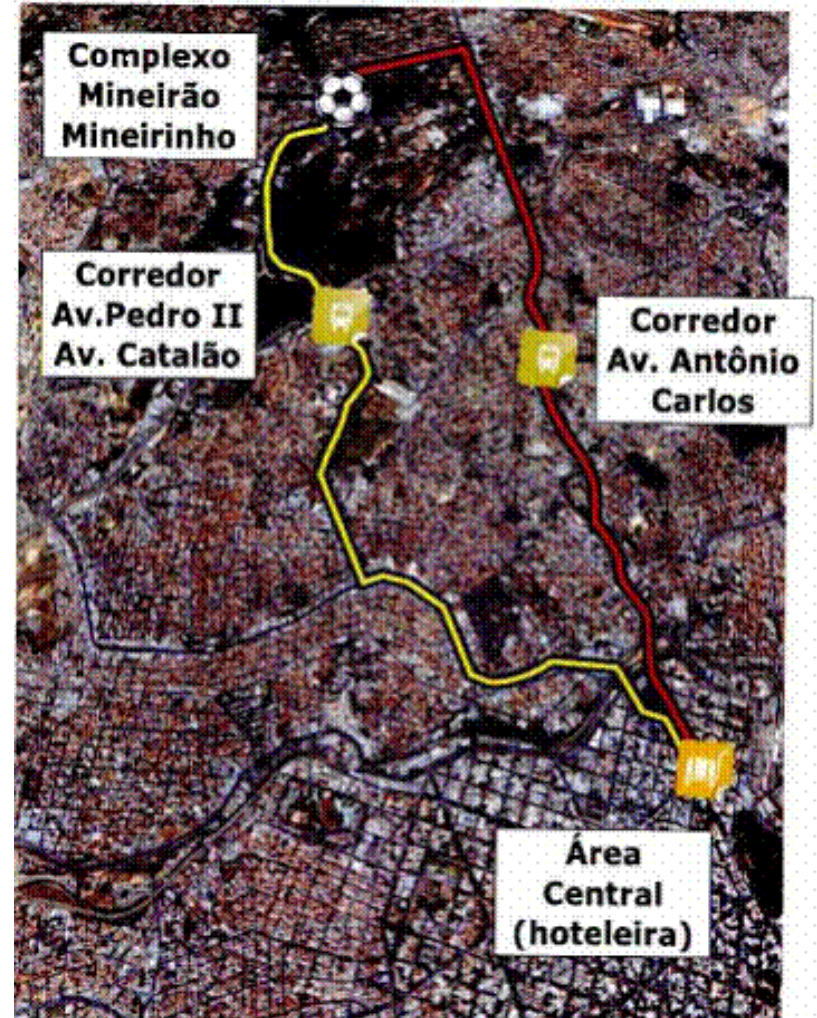
- » **Current capacity:** 250 thousand passenger/day.
- » **Capacity 2014:** 500 thousand passenger/day.
- » **Maximum capacity (2020):** 615 thousand passenger/day.
- » **Estimated cost:** R\$586 million.
- » **Conclusion:** Dec/2012.

## Corridor 2:

- » **Current capacity:** 135 thousand passenger/day.
- » **Capacity for 2014:** 270 thousand passenger/day.
- » **Maximum (2020):** 360 thousand passenger/day
- » **Estimated cost:** R\$279 million.
- » **Conclusion:** Jul/2012

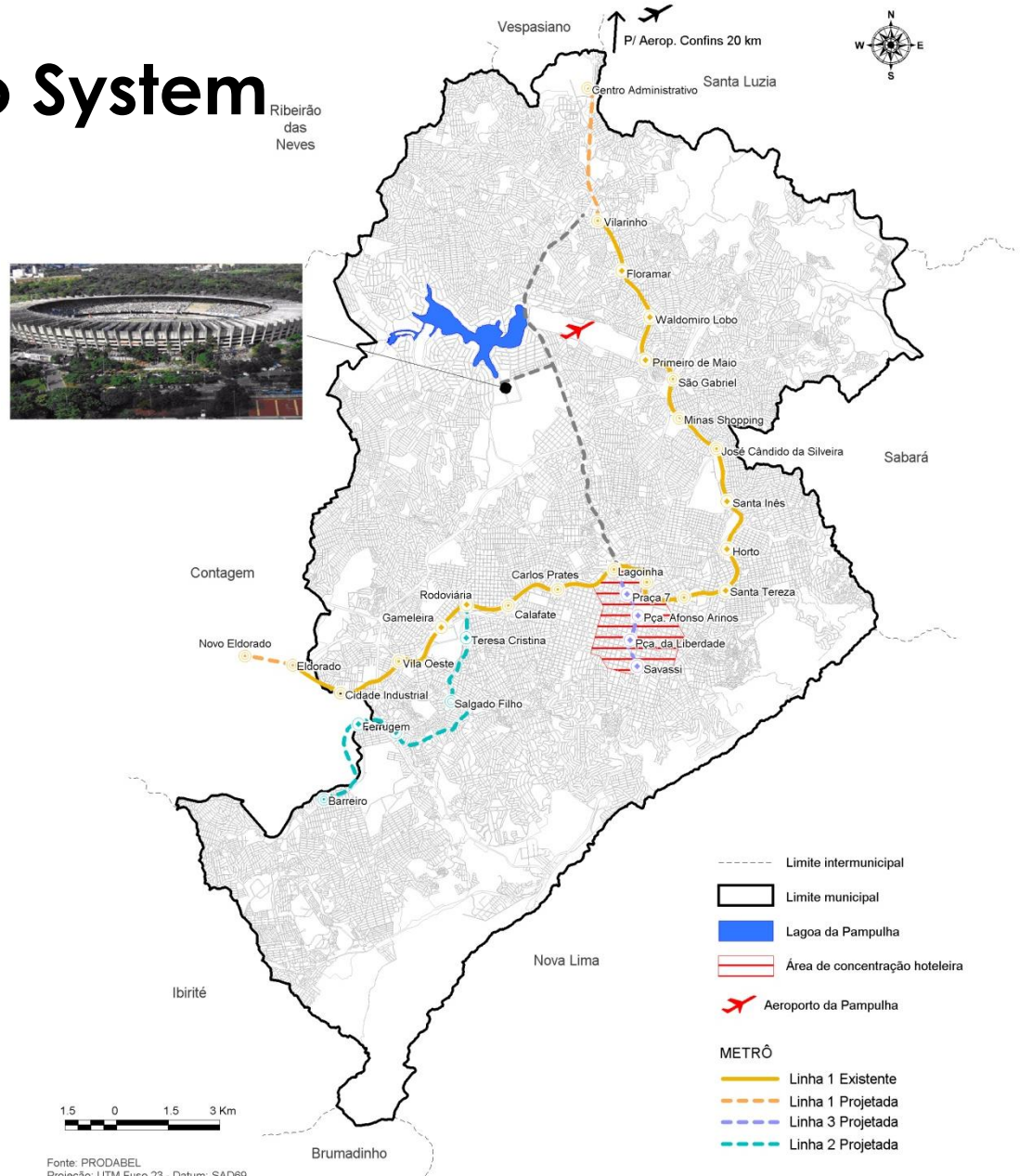

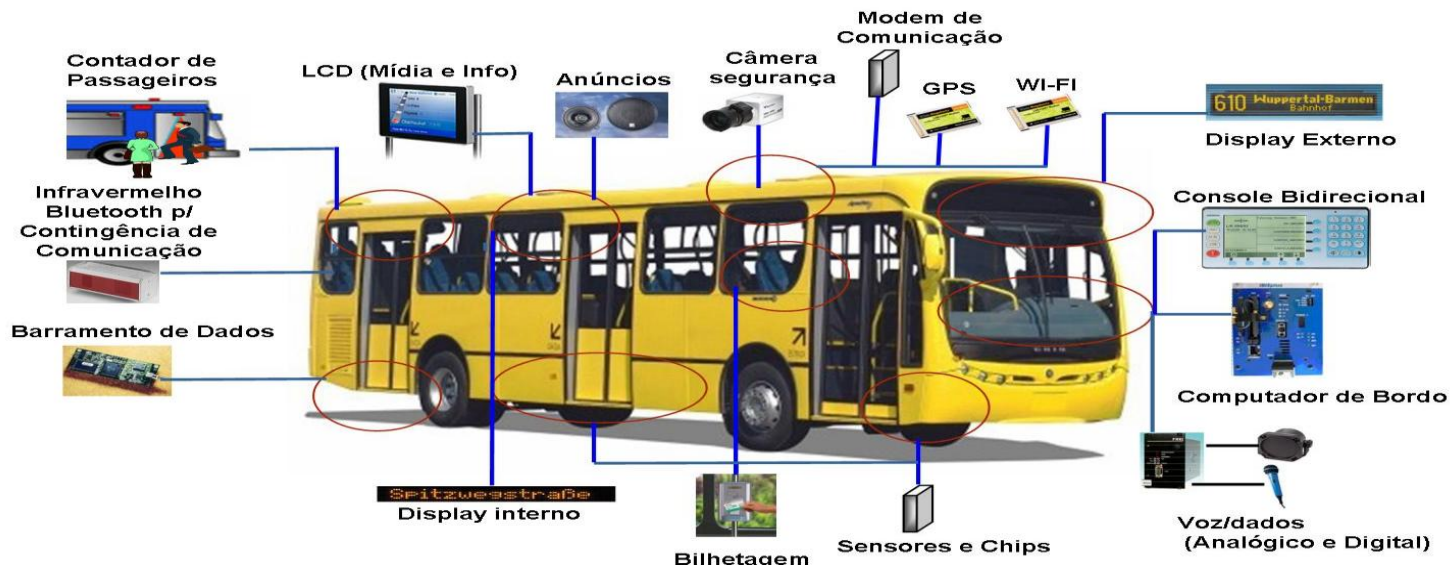
# Modernizing MRBH system
