Outstanding Public Transportation CEO Award This award honors the highest ranking staff member of an APTA public transportation system member who has made outstanding contributions to the public transportation industry. This person's title could be general manager, executive director, president, chief executive officer, etc. The transit agency/organization must be an APTA member in good standing.

Outstanding Public Transportation Board Member Award

This award honors an individual serving on the governing board of an APTA public transportation system member who has made outstanding contributions to the public transportation industry. The board member must come from an APTA member transit agency/organization in good standing.

Outstanding Public Transportation Business Member Award

This award honors an individual, employed by an APTA public transportation business member who has made outstanding contributions to the public transportation industry. The business member must be from an APTA organization in good standing.

Distinguished Service Awards

This award honors a public transportation decision maker; elected or appointed official; or private citizen who has contributed to the public transportation industry on the national, state or local levels through policy, legislative initiative, and leadership. This person may not necessarily be an APTA member, but is someone who has worked closely with the public transportation industry.
