# The APTA Bus and Transit Rail Safety Management Audit Programs

allow transit agencies to continuously improve system safety and assist in preparing for upcoming Federal and State safety audits, including those from a State Safety Oversight Agency (SSOA) and/or the Federal Transit Administration (FTA).

These programs are based on Safety Management Systems (SMS) criteria to reflect FTA requirements, including those published in the Public Transportation Agency Safety Plan (PTASP) at 49 U.S.C. Part 673, the National Public Transportation Safety Plan, and the State Safety Oversight Rule.

APTA's Bus and Transit Rail Audit Programs will provide agencies with a:

- · Review of the Agency's PTASP
- Discussion of SMS implementation
- Comprehensive checklist of where the agency is holistically with safety and security
- Application of APTA Industry Standards as well as recommended/best practices
- List of leading practices at the agency, as well as opportunities for improvement
- Discussion of the transit agency's opportunities for continual improvement towards achieving system safety



These programs are based on criteria to reflect requirements from FRA, including those published in the Part 270 System Safety Program.

Through the APTA Commuter Rail Safety Audit Program, railroads and commuter rail agencies from large to small will be provided with a comprehensive safety audit, that will provide a:

- Review of the Railroad's Part 270
   System Safety Program Plan
- Discussion of Safety Management Systems implementation throughout the organization
- Comprehensive checklist of where the agency is holistically with safety and security
- Overview of APTA Industry PRESS/Rail Standards as well as recommended/best practices
- List of leading practices at the railroad, as well as opportunities for improvement
- Discussion of the railroad's opportunities for continual improvement towards achieving system safety





Overall, APTA's Safety Management Audit program criteria is updated to reflect coverage of the most cutting edge and advanced safety issues in the public transportation and railroad industries.

# Rail (Heavy Rail, Light Rail and Streetcar) Safety Management Audit Program\*:

Small (0-2.49 mil trips/yr) +\$5,000 (30,000 total)

Medium (2.5-49.99 mil trips/yr) +\$10,000 (\$35,000 total)

Large (50 mil+ trips/yr) +\$15,000 (\$40,000 total)

### **Commuter Rail Safety Management Audit Program\*:**

AGENCY/SYSTEM SIZE COST

Small (0-0.99 mil trips/yr) +\$5,000 (30,000 total)

Medium (1-9.99 mil trips/yr) +\$10,000 (\$35,000 total)

Large (10 mil+ trips/yr) +\$15,000 (\$40,000 total)

\*Travel costs for each of the APTA Safety Management Audit Programs are also billed back to the requesting agency after the conclusion of an APTA Safety Management Audit.

Agencies that schedule multi-modal audits concurrently may also be eligible for a discount.
