Business Member Legislative/Procurement Committee Meeting Minutes

May 19, 2019

I. Call to order

Business Member Legislative Committee Chair Ray Melleady called to order the regular meeting of the Business Member Legislative/Procurement Committee at 7:01am on May 19, 2019 at the Omni Louisville in Louisville, KY.

II. Introductions

Attendees were: John Barberis, Christopher Boylan, Brad Carson, Freddie Fuller, II, Sharon Greene, Huelon Harrison, Frank DiGiacomo, Tony Kellen, James LaRusch, Firas Makhlouf, Jack Martinson, Raymond Melleady, Raquel Olivier, James Srygley, William Thomsen, Jeff Wharton, Rick Bacigalupo, John Hroncich, Larry Fuehrer, Bill Umbenhauer, John Fink, Stephanie Laubenstein, Mark Hybner, Nicole Christus, David Carol.

III. Approval of minutes from last meeting

Business Member Legislative Committee Chair Ray Melleady called for a motion to approve the previous meeting's minutes. A motion was made, seconded, and was voted on unanimously.

IV. Agenda items

- a) The anti-trust statement was read.
- b) Nicole Christus gave the legislative update. APTA President and CEO Paul Skoutelas sent correspondence to the U.S. House Appropriations Committee, highlighting APTA's priorities for transit. The U.S. House Transportation and Infrastructure Committee will be holding a hearing on the use of federal funds to procure Chinese-manufactured rolling stock. President Donald Trump and Congressional leaders are scheduled to meet regarding an infrastructure bill.
- c) The 2019 Business Member Fly-In was recapped; there were 38 participants, holding 82 meetings and the focus was on the Highway Trust Fund shortfall. The participants were thanked. Participants shared their experiences from that day.
- d) An update was given for the BMBG Strategic Plan; the plan has been finalized. A link to the document will be shared via the APTAconnect committee communities pages. The working group that helped create the document was recognized.

- e) The BMBG Advocacy Plan was discussed; letters have been sent to Congressional representatives from key opposition states, in collaboration with Advocacy Associates.
- f) Business Member Procurement Committee Chair Natalie Cornell sought feedback on Buy America compliance challenges. There was a report that automobile manufacturer Chevrolet is not able to meet the mandatory 70% content rule on a procurement they are fulfilling for Washington State.

V. New business

- a) The committee was asked to review the draft version of an advocacy request document, as well as the proposal to fund transit opposition research.
- b) Costs have gone up 25% on imports, due to the Chinese tariff.

VI. Adjournment

Business Member Procurement Committee Chair Natalie Cornell adjourned the meeting at 8:01am.
