#### **PTSCTP Overview**

The PTSCTP Rule (49 CFR part 672) establishes a uniform safety training curriculum to enhance the Safety Management System (SMS) skills and knowledge of transit safety personnel.

#### This regulation applies to:

- State Safety Oversight Agencies (SSOAs) and their employees and contractors that conduct safety reviews, inspections, examinations, and other safety oversight activities
- Rail transit agencies (RTAs) and their employees and contractors that are directly responsible for the safety oversight of rail fixed guideway public transportation systems


#### **PTSCTP NPRM Overview**

FTA published three key proposed updates for the NPRM in the Federal Register, including:

Aligning definitions to reflect the proposed updates and with the existing regulatory framework

**Streamlining** PTSCTP training enrollment and **clarifying** voluntary PTSCTP participation and refresher training requirements

**Updating administrative requirements** by creating flexibility in course requirements and establishing a communication process



#### **PTSCTP NPRM Overview**

Stakeholders will have **60 days** to submit comments to the docket. Key areas of interest for public comment include:

The proposal to maintain the existing minimum training requirements for:

- SSOA personnel who conduct RTA oversight activities; and
- RTA employees and contractors directly responsible for the safety oversight of a rail fixed guideway public transportation system

Considering if future mandatory
PTSCTP participation **should extend to bus transit agencies** and personnel

# New Definitions (1 of 2)

FTA proposes six new definitions which do not impact existing requirements and are added to provide clarity. These new definitions are:

New Items	Justification
Initial training (§ 672.5)	Clarify the phrase used to define which courses must be completed within three years of enrollment
PTSCTP curriculum (§ 672.5)	Clarify which courses must be completed to receive a certificate of completion
Rail transit agency (§ 672.5)	Synchronize the definition with its definition in other transit safety regulations

# New Definitions (2 of 2)

FTA proposes six new definitions which do not impact existing requirements and are added to provide clarity. These new definitions are:

New Items	Justification
Refresher training (§ 672.5)	<ul> <li>Complement the definition of initial training to clarify the training that must be completed every two years after completing the initial training</li> </ul>
Safety review (§ 672.5)	<ul> <li>Clarify the term used to identify mandatory PTSCTP participants at SSOAs</li> </ul>
Voluntary participant (§ 672.5)	<ul> <li>Clarify which individuals are not subject to the PTSCTP requirements and confirm that they may participate in the PTSCTP voluntarily</li> </ul>

## **Updated Definitions**

FTA proposes three updated definitions, which do not impact existing requirements and are added to provide clarity. These updated definitions are:

Updated Item	Justification
Federal Transit Administration (§ 672.5)	Synchronize the definition with other transit safety regulations
<b>Designated Personnel</b> (§ 672.5)	Clarify the applicability of RTA and SSOA employees and contractors
Rail fixed guideway public transportation system (§ 672.5)	Synchronize the definition with its definition in other transit safety regulations

# **New Training Requirements**

FTA proposes new enrollment requirements and refresher training requirements for designated PTSCTP participants. These new requirements include:

New Items	Justification
Enrollment requirements (§ 672.11(b) and .13(b))	<ul> <li>Require SSOAs and RTAs to ensure designated personnel are enrolled in the PTSCTP within 30 days of designation, to ensure timely obtainment of knowledge and skills</li> </ul>
Refresher training (§ 672.11(d) and .13(d))	<ul> <li>Maintain existing requirements for agency-defined training and add a component for refresher training defined by FTA to ensure adequate refresher training is completed</li> </ul>
Voluntary participants (§ 672.17)	Clarify existing processes related to PTSCTP voluntary participants and define what voluntary participation entails

# **Updated Training Requirements**

FTA proposes an update to clarify the evaluation processes for course equivalency submissions. This updated requirement is:

Updated Items	Justification
Evaluation of prior certification and	Clarify the process for evaluation of prior certification and training
<b>training</b> (§ 672.15)	

## **New Administrative Requirements**

FTA proposes establishing new administrative requirements for recipients subject to the PTSCTP rule. These new requirements include:

New Items	Justification
PTSCTP-related communication (§ 672.21)	Establish reporting requirements to support FTA's PTSCTP compliance monitoring
Point-of-contact (§ 672.21(b-d))	<ul> <li>Require SSOA and RTA recipients to identify a single point-of-contact for FTA regarding PTSCTP records</li> <li>Establish required responsibilities for point-of-contact</li> <li>Create semiannual reporting requirements for point-of-contact</li> </ul>

# **Updated Administrative Requirements (1 of 2)**

FTA proposes updating administrative requirements to clarify required courses and grantee responsibilities. These updated requirements include:


Updated Items	Justification
<b>Appendix A</b> (§ 672.21)	<ul> <li>Provide flexibility in course requirements by removing Appendix A from 49 CFR part 672 and instead publishing required courses on the FTA website</li> </ul>
<b>Grantee responsibilities</b> (§ 672.21(a))	Clarify applicable grantee responsibilities to ensure designated personnel meet the PTSCTP requirements

# **Updated Administrative Requirements (2 of 2)**

FTA proposes updating an administrative requirement for the SSOA Technical Training Plan (previously included in Appendix A). This updated requirement is:

Updated Items	Justification
Technical Training Plan (§ 672.21(e))	<ul> <li>Clarify the existing requirement for SSOAs to submit their Technical Training Plan to FTA</li> <li>Replace reference to "System Safety Program Plan" with "Agency Safety Plan"</li> <li>Require training records to include minimum passing scores to support FTA evaluation</li> </ul>
