1. Welcome and Introductions

a. Katherine Eagan Kelleman, Vice Chair; Chief Executive Officer, Port Authority of Allegheny County, Pittsburgh, PA

Katherine Eagan Kelleman called the meeting to order at 12:30PM.

2. Approval of March 17 Meeting Minutes

Vince Vales gave an update on the Integrated Mobility Innovation demonstration program issued May 8th. This project aims to take Mobility on Demand sandbox to the next level. Informational webinar is scheduled for May 22nd.

Kimberly Sledge gave an update on Passenger Ferry Notice of Funding Opportunity (Nofo) applications, tribal transit Nofo, and the Bus and Bus Facilities Nofo. Sledge also gave a CCAM update.

Anytime that people give up SOV travel, that would be considered a win for the transit agency. Skepticism is not the same as cynicism. New mobility is not necessarily greater than "old" mobility. Do not go for new tech just because it is trendy, but because it meets your goals. First-Mile/Last-Mile is an unhelpful term. Uber/taxis don't want to do short trips of a mile or less. This problem is really about poor land use, which is not just a public sector problem. Businesses

locating in expensive to serve area should not expect equal coverage. Modes serve different purposes (walk, bike, transit). Transit's specialty distance is over 3 miles.

Art Guzzetti led a conversation calling for developed response comments to proposed changes. It was noted that respondents should emphasize shared rides in new potential reporting. Ridership should not be the only metric considered when evaluating new mobility programs.
