Committee Goals and Tasks 2019 - 2020

Committee Goal 1: Agency Forum

- Goal description: Increase agency participation in technical forum
- List of APTA strategic goals supported: Workforce Development, Technological Innovation
- Key tasks to achieve goal
 - o Partner with other Technical Forums and Committees to raise the profile of the inherent value of the knowledge sharing and networking opportunities therein.
 - Establish dialogue with agencies about what can be done to lower barriers preventing agency participation and, if possible, attempt to lower those barriers
 - Engage agencies on ongoing issues to identify potential topics for further added value
 - o Provide more virtual connection opportunities
 - o Roll out improved presentation database with contact information of the presenters
 - o Add value to meetings by arranging for CEU opportunities
- Timeframe: Ongoing

Committee Goal 2: Industry engagement

- Goal description
 - o Provide problem statements to TCRP regarding emerging and ongoing industry challenges.
 - o Provide virtual engagement and education opportunities for topics as needed.
- List of APTA strategic goals supported: Workforce Development, Technological Innovation
- Key tasks to achieve goal:
 - o Create TCRP problem statements.
 - o Provide opportunities for virtual webinars based off unchosen abstract submissions from rail conference and from issues as they are raised within the technical forum.
 - Create standing abstract and content review sub-forum for webinar content
 - o Regular virtual meetings for technical forum.
- Timeframe: 6 months 2 years, ongoing

Committee Goal 3: Focus Goal 2019-2020 – Signaling Future/CBTC Analysis

- Goal description
 - o Produce in-depth analysis of the pros and cons of CBTC installation
- List of APTA strategic goals supported: Resource Advocacy, Technological Innovation
- Key tasks to achieve goal:
 - o Survey of agencies on experiences and plans related to CBTC installation. Ask about any concerns related to CBTC.
 - o Share survey results with forum and agency participants.
 - o Based on results, formulate plan on how to address issues identified by survey.
 - Option 1: Engage other APTA Committees on CBTC topics relating to their field of expertise (ex: for cybersecurity concerns, engage security committee)
 - Option 2: Raise concerns up through the APTA committee structure.
 - o Investigate issues raised by survey through literature reviews and disseminate updates via virtual meetings
 - o Produce in-depth analysis of the pros and cons of CBTC installation
- Timeframe: 2 years
