

- iTransit launched in 2015 as a "grassroots" effort designed to show support for public transit
 - Individuals signed up, were asked to contact their legislative delegation

SB 1 will provide approximately \$700 million annually to California's public transit systems, improving mobility in communities across the state. As our transit systems begin to implement projects and programs with these new revenues, it is important that Californians are aware of the benefits this funding provides. This vital funding is helping to #KeepCAMoving.

Broad coalition formed to oppose #SB1 repeal initiative aimed for November 2018

A broad-based coalition representing local government, business, labor, social justice advocates, community groups, public safety leaders, transportation advocates and taxpayers announced today a new coalition to oppose the initiative aimed at the November 2018 statewide ballot that would repeal the new transportation revenues authorized by the Road Repair and Accountability Act of 2017. The proposed repeal ballot measure is currently in the signature gathering phase and is being funded by certain Republican politicians. The coalition will also work to gain voter approval of Prop 69 on the June 2018 ballot, the constitutional amendment that will prevent the legislature from borrowing or diverting new transportation funds not already protected. The coalition announced it formed a new committee earlier this year, the Coalition to Protect Local Transportation Improvements and vowed to run an aggressive campaign to protect vital transportation investments... If Republicans have their way, California highways stand to lose big under Trump's infrastructure plan

President Trump's infrastructure proposal isn't worth much. And what it is worth for California, the state's Republican delegation in Congress is trying to destroy. That's the irony. More precisely, it's cynical politics outweighing needed public works. This is what I mean: Under Trump's plan, the federal government would pay for 20% of a major infrastructure project, such as a bridge repair. State and local governments would need to foot 80%... The Results


- SB 1 (Beall and Frazier) passed in California in April 2017
 - Provides \$700 million a year in new, dedicated \$\$ for public transit
 - When factoring in other competitive programs, \$\$ grow to more than
 \$1 billion annually
 - Largest influx of new transit funding in more than 40 years

The Evolving Role of iTransit

 After SB 1 passed, iTransit became a way to educate Californians on benefits of funding / transit, because...



SB 1 is in Danger

- In June 2018, opponents of SB 1 qualified Prop 6, a repeal initiative, which will be on the November 2018 ballot
 - Would undo all recently enacted SB 1 \$\$ / require a vote of the people to pass new transportation taxes & fees
 - Primarily backed by CA Congressional GOP / drive election turnout
- In response, CTA helped form the Coalition to Protect Local Transportation Investments

SB 1 is in Danger (Still)

- Coalition spearheaded by key groups
 - CTA, CA League of Cities, Assoc. of Counties, labor, contractors
 - Largely focused on polling / telling the good story
- Coalition working closely with Brown Administration, including our state's DOT / local electeds / local transportation agencies
- CTA has developed its own advocacy materials

ARTBA Study

- CTA-funded ARTBA Study on economic impacts of SB 1 released on February 28
- Study findings:
 - \$182 billion economic boost to California over next 10 years
 - \$15 billion boost to transit users (reduced congestion / savings from no driving)
 - 68,000 jobs each year
 - Annual savings of \$300 per household in California

Total Impacts of SB 1 over 10 Years	
User Benefits	\$38.2 billion
Highway, Street & Bridge	\$23.6 billion
Transit	\$14.6 billion
Economic Impacts	
Economic Output	\$111.8 billion
Earnings	\$32.6 billion
Employment	682,029 job-years
Total Impact	\$182.6 billion

Local Coalition Grant Funding

- CTA received \$9,000 grant from APTA
 - Funds used for combatting Prop 6/ telling the good story
 - Majority of funds spent in Summer 2018
 - We matched ~2:1 to keep up effort until November 2018
- Focus efforts on project specific / regionally specific promotions
 - Polling shows public cares most about projects in their backyard / congestions relief
 - Ran Pro-SB 1 iTransit ads in vehicles and in various social media outlets throughout CA – targeted the S.F. Bay Area, San Diego, Orange County
