

New Appropriations Bill Saves Transit Jobs

Investment in transportation infrastructure and transportation services has long been a favored policy option to aid economic recovery and accelerate employment growth. The 308,000 transit jobs maintained by the recent appropriations bill added \$30.8 billion in economic activity.¹

The Northeast Region (CT, ME, MA, NJ, NH, NY, PA, RI, VT) makes up 108,000 (33%) of the total number of transit jobs supported.

The West Region (AK, AZ, CA, CO, HI, ID, MT, NM, NV, OR, UT, WA, WY) makes up 87,600 (29%) of the total number of transit jobs supported.

The South Region (AL, AR, DE, DC, FL, GA, MD, NC, SC, VA, WV, KY, LA, MS, TN, OK, TX) makes up 71,400 (23%) of the total number of transit jobs supported.

The Midwest Region (IA, IL, IN, KS, MI, MN, MO, NE, ND, OH, SD, WI) makes up 46,200 (15%) of the total number of transit jobs supported.

The U.S. public transportation system currently consists of 7,200 transit service providers (public and private), operating 14 optional modes of service. This includes 5,300 service providers for elderly and persons with disabilities.²

An APTA study conducted in September 2011 suggested that a recent Congressional proposal to cut funding by 30% would have eliminated 620,000 private and public sector jobs over a six year period. Sustaining public transportation funding is critical to protect jobs and economic activity.

Procedure: Apportioned funds are distributed based on FY 2011 percentage distribution to each state/area. Multi-state distributions are assigned to each state using a population and population/density formula. Discretionary programs distributed based on average distributions for six-years. Jobs supported are calculated from 30,000 jobs for each \$1 billion in funding. Includes Direct, indirect, and induced jobs.
